- Do they monitor their clients' progress and provide aftercare services once you have been discharged from the facility?

How long will I have to stay at a Kentucky rehab center?

Being away from home and the people you love can be challenging, more so when you are recovering from addiction. As part of your research into rehabs in Kentucky, you should try and find out how long different addiction treatment programs run. Some go on anywhere from 3 months to a year or more. Your duration at a treatment facility in Kentucky, or anywhere else in the country, will depend on some factors. This includes the type of program you enroll for, how receptive you are to treatment as well as your stage of addiction upon admission.

How much would treatment cost?

Another major consideration when seeking out of state treatment for addiction is how much you'll have to pay for it. One of the reasons why Kentucky is a great addiction treatment location is that you can find a treatment facility that suits your budget. The amount you can expect to pay will depend on the rehab's location, the amenities offered, the type of addiction recovery program you sign up for, and whether or not you'll require other treatment procedures like detoxification or medically assisted treatment.

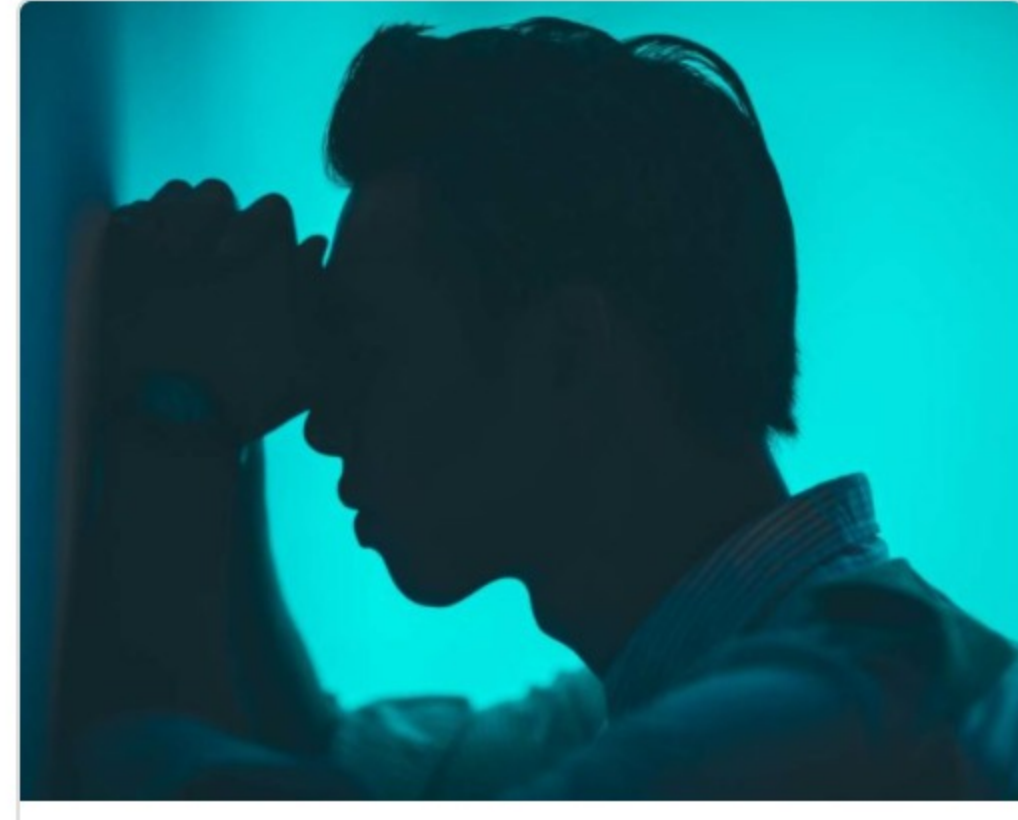
